MINUTES OF MEETING
RIVERS EDGE II COMMUNITY DEVELOPMENT DISTRICT

The meeting of the Board of Supervisors of the Rivers Edge II Community Development District was held on Wednesday, September 16, 2020 at 10:30 a.m. using *Zoom* media technology pursuant to Executive Orders 20-52, 20-69 and 20-193 issued by Governor DeSantis and pursuant to Section 120.54(5)(b)2., *Florida Statutes*.

The following is a summary of the discussions and actions taken at the September 16, 2020 meeting. An audio copy of the proceedings can be obtained by contacting the District Manager.

FIRST ORDER OF BUSINESS

Roll Call

Mr. Perry called the meeting to order.

SECOND ORDER OF BUSINESS

Public Comment

Mr. Fred Baron, 44 Cherry Laurel Place stated I would like the Board to address three items, if they can. One is the golf cart parking when you get to the RiverFront Park policies and where golf carts would be parked in the park area and whether there is any access for handicap individuals because it is quite a long walk if they are using one of the piers.

Staff informed Mr. Baron the RiverFront policies will be addressed during the Rivers Edge I meeting.

Mr. Fred Baron stated the second item I want to bring up is the billing aspect for reclaimed water. It's showing \$135K as a deficit, although it appears you've taken it out of the maintenance area for trees and growth, so I'd like it explained how you can make up that deficit. The third item is VerdeGo's billing. It doesn't show what was done out of the 12-month billing cycle and I'm wondering if you can put more detail into that and what was actually done for the month.

Mr. Perry responded I will have to address those items separately. Between meetings, if you have any specific questions you can convey those to me and we can get those answers to you. You don't have to wait for a meeting.

THIRD ORDER OF BUSINESS

Approval of Minutes

A. August 19, 2020 Regular Meeting

B. August 19, 2020 Continued Meeting

There were no comments on the minutes.

On MOTION by Mr. O'Keefe seconded by Mr. Henderson with all in favor the minutes of the August 19, 2020 regular meeting were approved.

On MOTION by Mr. O'Keefe seconded by Mr. Henderson with all in favor the minutes of the August 19, 2020 continued meeting were approved.

FOURTH ORDER OF BUSINESS

Acceptance of Engagement Letter with Grau & Associates for the Fiscal Year 2020 Audit

Mr. Perry stated we would ask that the Board approve this in substantial form. There are some minor edits that need to take place that were recommended by District Counsel.

On MOTION by Mr. O'Keefe seconded by Mr. Henderson with all in favor the engagement letter with Grau & Associates was accepted in substantial form.

FIFTH ORDER OF BUSINESS**Consideration of Towing Policy, Form of Agreement and Form of Authorization**

Ms. Gentry stated the Board is familiar with the policy by this point. The biggest change is that we have attached the map to the clean version of the policy that shows the areas that would be affected. As we've said before, this is only for established designated parking areas, and at this time the only established designated parking area in Rivers Edge II is at the RiverClub. As additional areas come online, we can add them to this policy. The other changes that we made were to clarify that this does not apply to private home lots or land that is owned by another governmental entity and to clarify that staff can grant exceptions. We have included a sample parking authorization that staff could use if someone made a request to park overnight at the RiverClub.

Mr. O'Keefe asked when it comes to the enforcement, the first offense with the written warning being placed on the vehicle, is there a time window that is associated with placing that warning on the vehicle before towing is allowable?

Ms. Gentry stated written warnings typically give 24-48 hours to move the vehicle. There's not a statutory requirement for that and we've not specified it in this policy, but the warning would give the period of time to move the vehicle. I also want to point out that if staff is concerned the vehicle is posing a safety danger or under certain other emergency circumstances, we are able to skip that initial written warning.

Mr. O'Keefe asked this is not an expense for the District?

Ms. Gentry stated that is correct. The cost is born by the person whose car is towed.

On MOTION by Mr. O'Keefe seconded by Mr. Henderson with all in favor the towing policy was approved.

Ms. Gentry stated the next step would be to enter into an agreement with a towing company where they agree to come and tow upon request and install the necessary signs for us.

On MOTION by Mr. O'Keefe seconded by Mr. Smith with all in favor the form of agreement and form of authorization were approved in substantial form with the Chairman authorized to execute the agreement once an appropriate vendor is found.

SIXTH ORDER OF BUSINESS**Staff Reports****A. District Counsel**

Ms. Gentry stated we are still waiting to see if the Governor will extend the in-person quorum waiver past the end of this month. We will continue to monitor that and keep the board apprised.

B. District Engineer

There being nothing to report, the next item followed.

C. District Manager – Consideration of a Regular Meeting Schedule for Fiscal Year 2021

Mr. Perry noted the meeting schedule included in the agenda package has been revised from what was presented at the previous month's meeting to include a meeting time of 10:00 a.m.

On MOTION by Mr. O'Keefe seconded by Mr. Smith with all in favor the meeting schedule was approved as presented.

D. General Manager - Report

Mr. Jason Davidson informed the Board the café is scheduled to open the weekend of October 2nd with a new menu. Mr. Davidson also requested moving the RiverClub hours of operations from 10:00 a.m. to 8:00 p.m. Tuesday through Sunday to 10:00 a.m. to 8:00 p.m. Tuesday through Thursday, and 10:00 a.m. to 9:00 p.m. Friday through Sunday to coincide with the hours of operation of the café.

On MOTION by Mr. O'Keefe seconded by Mr. Smith with all in favor adjusting the hours of operation for the RiverClub to 10:00 a.m. – 9:00 p.m. Friday through Sunday was approved.

Mr. Jason Davidson suggested doing away with the reservation system for participation at the RiverClub. The current capacity limit of 80 people on the pool deck would remain and would be use at your own risk.

On MOTION by Mr. O’Keefe seconded by Mr. Smith with all in favor removing the requirement for reservations for use of the RiverClub was approved.

Mr. Jason Davidson requested to reinstate programming for water aerobics and outdoor events with capacity limits.

Ms. Gentry recommended reinstatement of the programs and/or events be subject to social distancing and possibly requiring COVID waivers.

On MOTION by Mr. O’Keefe seconded by Mr. Henderson with all in favor reinstating the water aerobics program, subject to appropriate COVID precautions was approved.

Mr. Jason Davidson requested reactivation of rentals of the café during non-hours of operations with a capacity limit of 50%, monitoring by staff, and requirement of execution of waivers.

Mr. Perry suggested tabling consideration of the request until the next meeting to allow staff to gather more information and suggested rental agreement language.

Mr. Jason Davidson asked for the Board’s opinion on reinstating District events.

Mr. Perry noted while some districts have begun planning events again, most have decided to hold off at least until December or January. Consideration of reinstating district events was tabled.

E. Landscape Report

Mr. Beladi informed the Board the jasmine beds in the parking lot and the roses out front have been declining since they were planted and suggested installing grasses. Mr. Jason Davidson noted staff would work with VerdeGo to prepare a proposal to submit to the Board for consideration.

FOURTH ORDER OF BUSINESS

**FIRST AMENDMENT TO THE
AGREEMENT BETWEEN THE RIVERS EDGE II COMMUNITY DEVELOPMENT
DISTRICT AND VESTA PROPERTY SERVICES, INC. FOR AMENITY
MANAGEMENT AND FIELD OPERATION SERVICES**

This First Amendment to the *Agreement between the Rivers Edge II Community Development District and Vesta Property Services, Inc. for Amenity Management and Field Operation Services* (the “**Amendment**”) is made and entered into this 21st day of October 2020, by and between:

Rivers Edge II Community Development District, a local unit of special purpose government established pursuant to Chapter 190, *Florida Statutes*, located entirely within St. Johns County, Florida, and with a mailing address of 475 West Town Place, Suite 114, St. Augustine, Florida 32092 (the “**District**”); and

Vesta Property Services, Inc., a Florida corporation, with offices located at 245 Riverside Avenue, Suite 250, Jacksonville, Florida 32202 (the “**Contractor**” and, together with the District, the “**Parties**”).

RECITALS

WHEREAS, the District and the Contractor previously entered into that certain *Agreement between the Rivers Edge II Community Development District and Vesta Property Services, Inc. for River Club Amenity Management and Field Operation Services*, dated October 1, 2019 (the “**Agreement**”); and

WHEREAS, pursuant to the Agreement, the Contractor agreed maintain throughout the term of the Agreement insurance in the amounts specified in Section 12 of said Agreement; and

WHEREAS, given the nature and scope of the services provided, the Parties are agreeable to reducing the required abuse/molestation insurance coverage from \$5,000,000 to \$2,000,000; and

WHEREAS, the Parties wish to amend the Agreement to reflect said reduction.

NOW, THEREFORE, based upon good and valuable consideration and the mutual covenants of the parties, the receipt of which and sufficiency of which are hereby acknowledged, the District and the Contractor hereby agree as follows:

1. **RECITALS.** The foregoing recitals are true and correct and by this reference are incorporated as a material part of this Amendment.

2. **INSURANCE.** Section 12.A.vii. of the Agreement is amended as follows (omitted language indicated by strikethrough, added language indicated by underlining):

Abuse/Molestation coverage in the amount of ~~\$5,000,000~~ \$2,000,000.

All other insurance requirements contained in Section 12 of the Agreement remain in full force and effect.

3. **AUTHORITY.** By execution below, the undersigned represent that they have been duly authorized by the appropriate body or official of their respective entity to execute this Amendment, and that the respective parties have complied with all requirements of law and have full power and authority to comply with the terms and provisions of this Amendment.

4. **CONFLICTS.** The Agreement remains in full force and effect, except to the extent expressly amended pursuant to this Amendment.

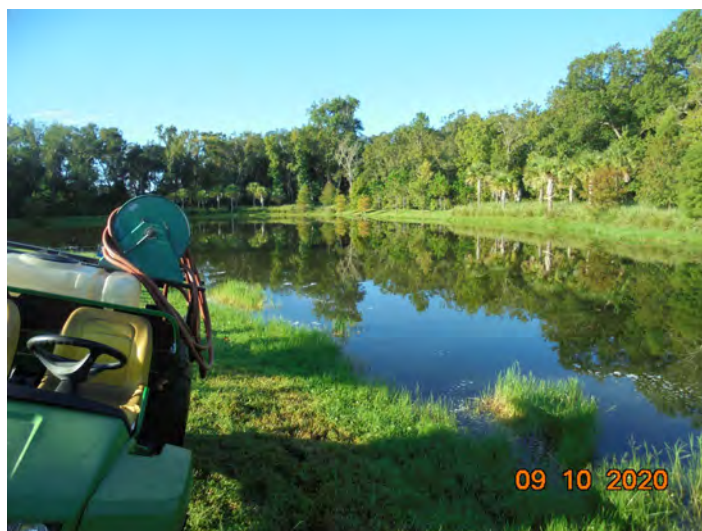
